**[PROPOSED] JUDGMENT**

1 Pursuant to the Order Confirming Final Arbitration Award entered on  
2 July 23, 2019 (Dkt. 137) and the Findings of Fact and Conclusions of Law entered  
3 on February 4, 2020 (Dkt. 148),

4 THE COURT HEREBY ORDERS, ADJUDGES, AND DECREES AS  
5 FOLLOWS:

6 1. The Final Arbitration Award in favor of Plaintiff Syscom (USA) Inc.,  
7 a California corporation (“Plaintiff”) and against Defendants Nakajima USA, Inc., a  
8 California corporation, Neko World, Inc., a California corporation, and Torrance  
9 Trading, Inc., a California corporation (collectively, the “Corporate Defendants”) is  
10 confirmed.

11 2. Judgment is entered in favor of Plaintiff and against the Corporate  
12 Defendants, jointly and severally, in the amount of

13 (A) US\$615,894.05 in damages;

14 (B) US\$405,581.27 in attorney’s fees;

15 (C) US\$207,248.11 in interest through May 16, 2018; and

16 (D) US\$40,034.38 for ICDR fees and the arbitrator’s compensation  
17 and expenses,

18 for a total award of \$1,268,757.81 inclusive of interest through May 16, 2018, plus  
19 interest of US\$4,619.20 per month thereafter until entry of judgment.

20 3. Plaintiff is the “prevailing party” against the Corporate Defendants for  
21 purpose of recovery of attorney’s fees and costs, to the extent allowed and  
22 separately awarded.

23 4. Judgment is entered in favor of Defendant Shinji Nakajima  
24 (“Mr. Nakajima”) and against Plaintiff.

25 5. Plaintiff shall recover nothing from Mr. Nakajima.
